Partial Auction Terms:

- Submission of this form must be accompanied by a deposit of Ten Thousand Dollars (\$10,000) in certified funds or cash. If this form is submitted electronically the deposit must be delivered to Alderfer Auction within 24 hours of the submission or by the end of the first business day following the submission. The deposit will be held by Alderfer Auction until the day of auction.
- The balance of the purchase price will be due at settlement. Settlement to occur on or before January 11, 2024.
- A Buyer's Premium of 10% will be added to the winning bid/hammer price. The winning bid/hammer price plus the 10% Buyer's Premium will equal the total purchase price.
- The Real Estate Transfer Tax will be calculated based on the purchase price and divided equally between Buyer and Seller.

- Alderfer Auction will pay 2 ½ % commission to the real estate brokerage securing the winning bidder. The 2 ½ % commission is calculated on the opening bid submitted on this signed Broker/Agent Registration form. This form must be submitted to Alderfer Auction a minimum of 24 hours prior to start of the live auction. All submitted bids will be executed at the auction. If duplicate bids are received, the earliest bid submitted at that bid price will be executed. All bidders may continue to bid above their opening bid at the live auction, however, commission will be paid on the opening bid listed below.
