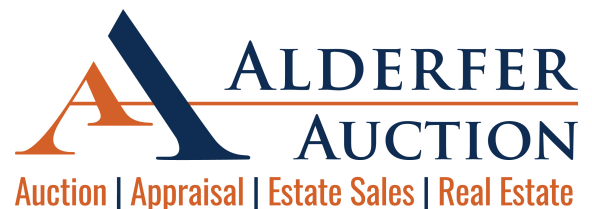

10. Firearms

Registration Fees

Firearm Laws

FFL Dealers and out-of-state buyers must have in their possession on the day of sale, signed copies of their Federal Firearms License in order to accept same-day delivery of modern firearms. Buyers who act as agents for FFL dealers must have a letter of agency as well as a signed copy of the dealers Federal Firearms License (FFL). Internet bidders who are out-of-state buyers and FFL dealers must email or fax a current FFL license within 24 hours of the close of the sale to Alderfer Auction email at shipping@alderferauction.com. Curio & Relic FFL licenses will be accepted on auction lots indicated in the description "(C&R)".

Curio and relic (C&R) firearms: The ATF has recognized only complete, assembled firearms as curios or relics. ATF's classification of surplus military firearms as curios or relics has extended only to those firearms in their original military configuration.
