KNOW ALL MEN BY THESE PRESENTS, That ROBERT C. SIMMONS, JR and wife
RUTH F. SIMMONS

for and in consideration of the sum of ONE HUNDRED and NO/100 Dollars
(\$ 100.00) to them in hand paid by Alabama Power Company, a corporation, the receipt of
which is hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns,
the right to implant, install and maintain anchor # of wood or other material at SWO point # on the
property hereinafter described, and to construct, extend and maintain guy wires from said anchors to struc-
tures now erected or hereafter to be erected on said land. Said anchors and guy wires to be located on and
across lands of the undersigned in the County of CALHOUN State of Alabama:

The lands on which said anchor # and guy wires are to be implanted or installed are described as follows:
A parcel of land situated in the SW 1/4 of the SE 1/4 of Section 17, Township 15 south,
Range 8 east and bounded as follows: on the east by Alabama Highway 21; on the
south by property of Lenora Cooper at #1; Hillcrest Road and property of Donald
C. Flood; on the West by right of way of Southern Railroad; on the North by prop-
erty of Perry Hill, a corporation.

Grantee, on request of grantor or successor in title, agrees to relocate one time
at its expense the stub pole, guy and anchor right-of-way for which is herein
granted to other location on property of the Grantor. Such other location to be
engineeringly acceptable to Alabama Power Company and the right to relocate such
stub pole, guy and anchor is hereby granted.

TO HAVE AND TO HOLD the same to the said Alabama Power Company, its successors and assigns, for-
ever.
