RIGHT-OF-WAY AGREEMENT

FOR AND IN CONSIDERATION of the sum of Ten Dollars, to us in hand paid, receipt of which is hereby acknowledged, the undersigned Grantor(s) Arkansas State Bank, Clarksville, Arkansas, whose address is P. O. Box 100, Clarksville, Arkansas 72830, does hereby grant to Arkansas Oklahoma Gas Corporation, an Arkansas corporation, its successors, or assigns, the exclusive right-of-way to lay, maintain, alter, repair, operate, replace, change the size of and remove pipelines for the transportation of oil or gas, or products of oil or gas and to construct meter facilities and other appurtenances, including cathodic protection facilities within said right-of-way, if the same shall be found necessary on, over and through certain lands situated in the County of Logan, State of Arkansas, described as follows:

The North Half (N/2) of the twenty (20') foot alley running east and west between McCandless Avenue and Grant Avenue in Block 12, as shown by a Choctaw, Oklahoma and Memphis Townsite Company's Supplemental Plat to the City of Booneville, Arkansas.

A total distance of 300 feet, (18 rods) more or less in length with ingress and egress to and from the same. The said Grantor(s), heirs or assigns, to fully use and enjoy the said premises except for the purposes hereinbefore granted to the said Grantee, who hereby agrees to pay any damages which may arise to timber, crops, asphalt, and other improvements, and fences from laying, maintaining and operating said line.

The Grantor(s) hereby covenant with the Grantee, his, her or their heirs and assigns, that said Grantor(s) are lawfully seized in fee of the aforegranted premises; that they are free from all encumbrances; that said Grantor(s) have a good right to sell or convey the said right-of-way to said Grantee and that said Grantor(s) will forever warrant and defend the title to said real estate against all lawful claims and demands whatsoever.
