Rawn, husband and wife, tenants in common, owners of the real estate described in Book 537 of Land Deeds, Page 334; The National Bank of Waterloo, owner of the real estate described in Book 487 of Land Deeds, Page 290; G. P. Schoenfelder of Arizona, owner, owner of the real estate described in Book 498 of Land Deeds, Page 658;* and McGregor Building Company, owner of the real estate described in Book 535 of Land Deeds, Page 407; all in the office of the Recorder of Black Hawk County, Iowa; hereby reserve and establish permanent easements for their mutual benefit and for the benefit of their successors in interest in the ownership of said properties and of such public and private corporations and agencies as may have occasion to serve, service, or supply any of said properties with water, sewer, gas, electricity or communication services, as follows:

1. For storm sewer, the real estate described in Exhibit "A", hereto attached;
2. For ~~electric and telephone transmission~~ electric and telephone transmission lines, the real estate described in Exhibit "B", hereto attached;
3. For electric transmission lines, the real estate described in Exhibit "C", hereto attached;
4. For sanitary sewer, natural gas, and telephone transmission lines, the real estate described in Exhibit "D", hereto attached;**

Any company or agency supplying electricity or communication service within the easements described in Exhibits "B", "C" and "D" shall have the right to construct, maintain and operate permanent underground electricity or communication feeder or service facilities with appurtenances thereto; and The City of Waterloo and any public utilities company having a franchise for the distribution and sale of gas in said City, shall have the right to construct and maintain sewer, water, and gas service lines in, across and along the easements described in Exhibits "A" "B" and "D". The proprietors, agents and workmen of all such service corporations or agencies shall have the right of reasonable access to their said services and installations for the purpose of the proper construction and maintenance of their lines and equipment.

These easements are to be permanent and to run with the land.




