ORDINANCE NO. 242

AN ORDINANCE VACATING AN ALLEY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CASEY, ILLINOIS:

WHEREAS, so much of the alley running in an East-West direction through Block Six (6) in Lang's Addition to the Town (now City) of Casey, Illinois, and being bounded on the North by Lots One (1), Two (2), Three (3) and Four (4) and on the South by Lots Five (5), Six (6), Seven (7) and Eight (8) in said City is no longer needed as a public alley and has not been used as a public alley for many years; and

WHEREAS, there is no need for said alley to be open and the public interest will be served by vacating said alley; and

WHEREAS, it is within the power and right of said City to vacate said alley as provided by Chapter 24, Sections 11-91-1 and 11-91-2 of Illinois Revised Statutes, 1969.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF CASEY, ILLINOIS that the public alley running in an East-West
direction through Block Six (6) of Lang's Addition to the Town (now City) of Casey,
Illinois, and being bounded on the North by Lots One (1), Two (2), Three (3) and
Four (4) and on the South by Lots Five (5), Six (6), Seven (7) and Eight (8) be and
the same is hereby vacated and closed as a public alley in the City of Casey, Illinois
effective with the date of passage hereof.

BE IT FURTHER ORDAINED that title to and ownership of said alley herein vacated shall be in the parties now owning the property abutting thereon equally as provided by Chapter 24, Sections 11-91-1 and 11-91-2 of Illinois Revised Statutes, 1969.
