RIGHT OF WAY PERMIT

In consideration of One Dollar (\$1.00) cash, receipt of which is acknowledged, and the benefits which will accrue to the property by the availability of electric service, I (we) hereby grant unto Louisiana Power & Light Company, its successors and assigns, the right and servitude to construct, operate and maintain electric lines, including poles, wires and other appurtenances, and to attach the wires of any other person or company to such poles, and to trim and cut trees and other growth so as to keep the wires cleared, and to cut down from time to time all dead, weak, leaning or dangerous trees that are tall enough to reach the wires in falling; upon, over and across the property which I (we) own, or in which I (we) have an interest in the Parish of Claiborne State of Louisiana, and more particularly described as follows:

A Tract of Land containing 2.85 Acres, more or less, situated in the Southwest Quarter of Southeast Quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 14, Township 21 north, Range 7 West.

The approximate location of right of way herein granted is shown in Red on grantee's Drawing No. AN5051, a copy of which is attached hereto and made a part hereof.

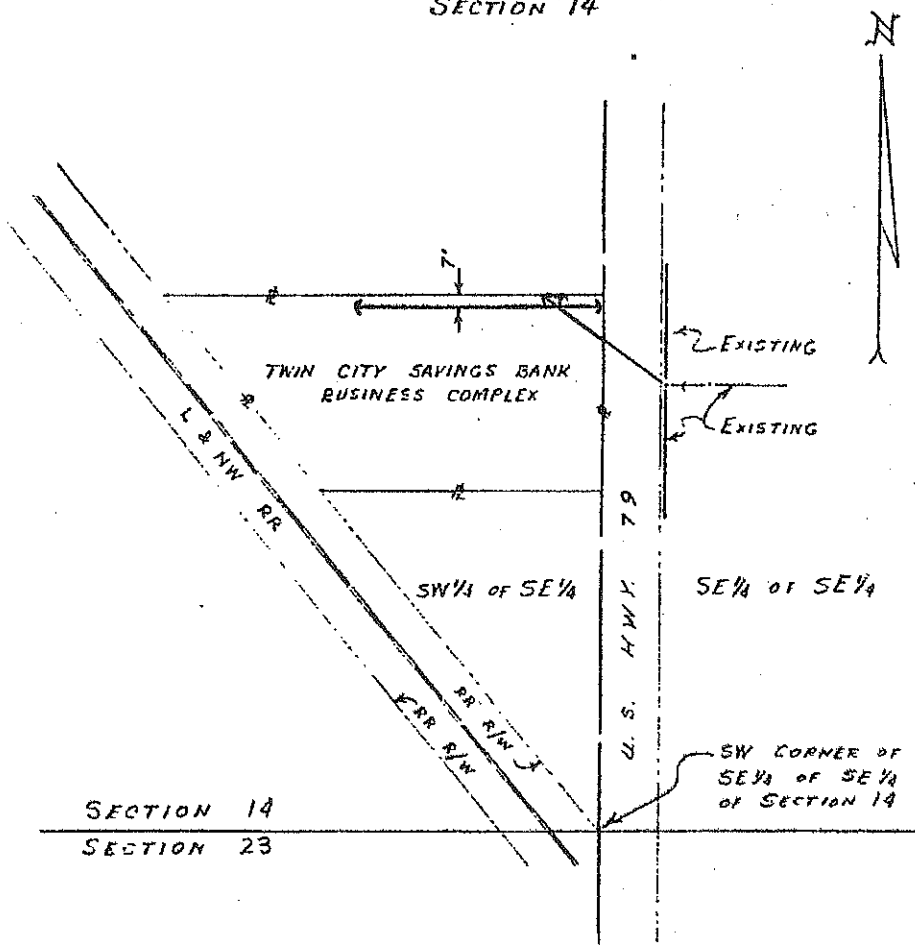
