Dear Mr. Ciaramitaro:

ARCADIS U.S., Inc. (ARCADIS) conducted a Complete Interior Survey (CIS) of asbestos-containing building materials (ACBMs) at the above-referenced building for Bank of America. The survey was requested by Salvatore Ciaramitaro of Jones Lang LaSalle to identify the location and quantity of ACBMs in the building. The focus of the survey was to identify visible and accessible suspect ACBMs. Background information on the Site, a summary of the asbestos survey as well as the inspector's certification and license are provided below.

#### **BACKGROUND INFORMATION**

The site is a 1-story building with a basement level located at the corner of Main Street and West Avenue in Newfane, New York. The building is owned by Bank of America and managed by Jones Lang LaSalle. The building totals 4,446 square feet and includes an attached drive-through canopy to the north side of the building. The building was constructed in 1950. The Site building consists of wood frame construction with concrete and brick exterior walls and glass windows. Interior finished walls are primarily drywall with associated joint compound and/or wall plaster finished with paint or wallpaper. Ceilings are comprised of 2' x 2', 2'x4', and 1'x1' suspended acoustic ceiling tiles, fiberboard, plaster, and/or drywall with associated joint compound. The flooring is a mixture of vinyl floor tile with mastic and/or carpeting overlaying the concrete floor. Thermal System Insulation (TSI) was present in the form of fittings and pipe insulation on pipes located above the ceiling and in mechanical spaces throughout the building. #### **ASBESTOS SURVEY**

Prior to the commencement of the CIS, ARCADIS reviewed asbestos survey data, if available, in Bank of America's IDEA system. As indicated herein, there were no existing previous asbestos survey data. Data generated during this survey was input into a Homogeneous Application Table (HAT).

The survey was performed on August 26, 2010 by Mr. Robert Mosher. A copy of his asbestos inspector license is provided in Attachment A. During the inspection, a total of 36 homogeneous applications (HAs) were identified and a total of 108 bulk samples were collected and submitted for laboratory analysis. The results of the CIS are presented in the Attachments to this report as follows:

- Attachment B Homogeneous Application Table
- Attachment C Laboratory Data Package and Chain of Custody
- Attachment D Floor Plans indicating sampling locations
- Attachment E Photographs of the HAs

Consistent with Bank of America's scope for a CIS, unless noted herein, destructive testing was not performed at the site in order to identify materials which may be hidden or obstructed. Examples of potentially hidden or obstructed areas include but are not limited to wall cavity interiors, pipe chases, spaces above fixed ceilings, grout/adhesive beneath ceramic tiles/marble tiles/granite, sub floors, and adhesives behind wall mounted mirrors, etc. The survey did not include roofing and the exterior of the building. Refer to the buildings Asbestos Operations & Maintenance Plan (OMP) in IDEA regarding potentially hidden, obstructed or non-sampled ACBMs.

For buildings constructed post-1990 (i.e. 1991 or more recent) or when renovations have occurred post-1990, consistent with the scope for a CIS, ARCADIS only sampled "specified materials" (flooring, mastics, etc.). Materials such as TSI, spray-applied fireproofing, suspended ceiling tiles, gypsum wallboard and joint compound were not sampled in post-1990 buildings.

#### CONCLUSIONS

As presented in the HAT in Attachment B, the results of the CIS identified ACBMs in the building.

When reviewing the HAT, in general, materials confirmed as ACBMs are identified by the National Emission Standards for Hazardous Air Pollutants (NESHAP) categories (refer to the NESHAP column of the HAT):

- Friable RACM
- CAT 1 Non-friable RACM
- CAT 2 Non-friable RACM

In some cases, materials which may be ACBMs could not be sampled and are identified as "Suspect ACM, Not Sampled" in the HAT. Until determined otherwise, suspect and not sampled ACBMs should be treated as asbestos-containing in accordance with the buildings asbestos Operations & Maintenance (O&M) Program (refer to the asbestos OMP in IDEA).

Materials confirmed as non-ACBMs are identified by the NESHAP categories:

- Non-ACM, Sampled
- Assumed Non-ACM, Not Sampled

#### RECOMMENDATIONS

ARCADIS recommends that all suspect and confirmed ACBMs, if present, be managed in accordance with an O&M Program. In most cases, when an ACBM is in "Good" condition, we anticipate that the material can be managed under the Operations and Maintenance program in-place with abatement only being required when materials will be disturbed (i.e. renovation and some maintenance activities).

#### CLOSING

The CIS described herein was conducted by the undersigned of ARCADIS. ARCADIS' investigation consisted solely of the activities described herein and is subject to the Limitations and Service Constraints in Attachment F. Prior to performing renovation or demolition activities, the existing data should be reviewed to confirm all building materials which may be impacted have been evaluated to determine if they are ACBMs and that the existing data is complete and complies with all laws and regulations. In some cases, additional testing, including destructive testing, may be required prior to demolition or renovation activities, especially with respect to potentially hidden, obstructed or non-sampled ACBMs. Contact the

Floor Plans





NEW FANE BARK 8/26 1 = T FLOOR




