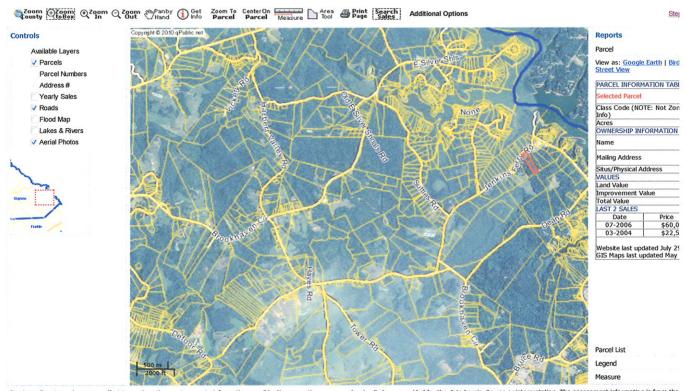


Stephens Home Search Return To Starting Point Street View(If available)
