The undersigned shall be liable as principal debtor and not merely as surety, and the bankruptcy or any assignment in favor of the creditors of Dealer shall not affect the enforceability of this guaranty.

This guaranty shall bind the respective administrators, executors, heirs, and assigns of the undersigned and shall insure to the benefit of Beach Ford, Inc., its successors, assigns, and subrogees.
