## DEED

WITNESSETH, that in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, in hand paid, the receipt whereof is hereby acknowledged, the Grantor does hereby grant and convey the following described premises to the Grantee(s), their heirs, representatives and assigns:


