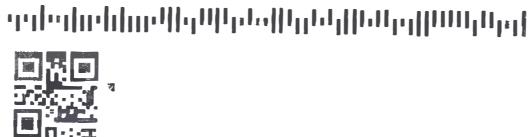

The registration card is the Certificate of Number and must be carried aboard whenever the vessel is in use. (Suggestion: Attach your vessel key chain with a floating device to your registration card. Your key and certificate will be in one place and will float if dropped overboard.)

The registration number assigned to your vessel must be painted or attached to both sides of the forward half of the vessel. The decals issued with your registration must also be attached one on each side of the vessel, immediately preceding the registration numbers. Only this number and decal must be displayed on the bow. When displayed, the numbers must be of contrasting color to the background on which they appear. The numbers must be in block characters reading from left to right and at least three (3) inches high, and not further apart than the width of the numbers used.

Change of Ownership: When the ownership of a registered vessel changes, O.C.G.A. 52-7-5 requires the prior owner to notify DNR within 15 days of such change. Additionally, the new owner is required to transfer the registration into their name. The registration numbers remain with the vessel.

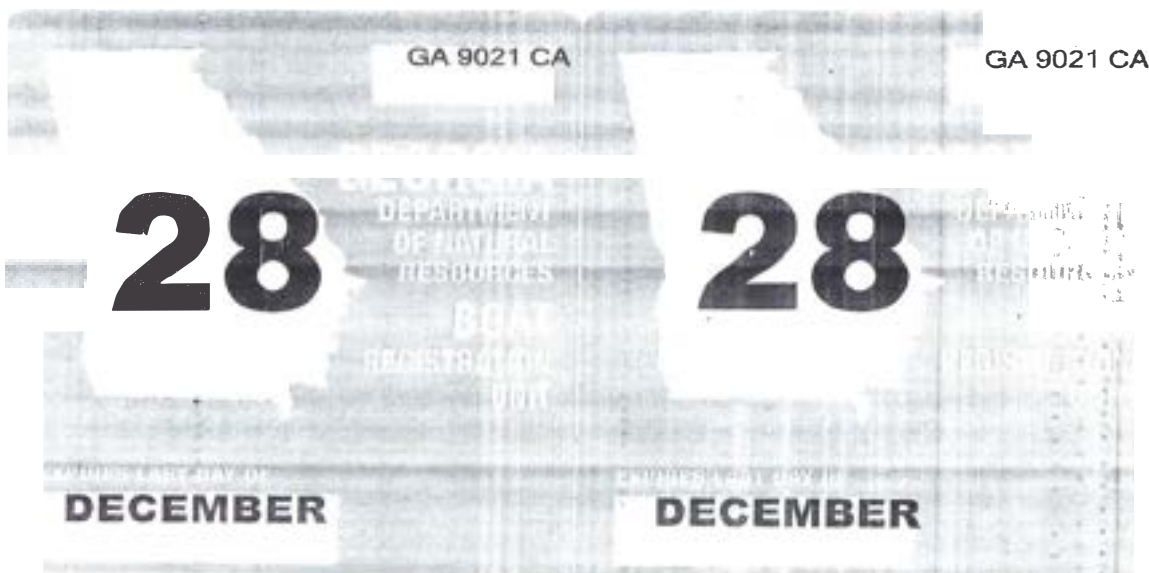
MOUNTING INSTRUCTIONS

1. Apply only to clean, dry, smooth, wax-free surface of moderate temperature.
2. Remove backing from decal and hold top of emblem in place. Firmly press into place and smooth down from top to bottom making sure no bubbles appear.

Destroy Original Title after registration is complete. For brand new boats never used before, this will be a Receipt from a Dealer or Bill of Sale from the Dealer. For USCG Documented vessels, this will be the Certificate of Documentation from the Coast Guard. For most other reasons, an Affidavit of Vessel Ownership is required. For inherited boats, use the Affidavit of Inheritance of a Vessel and provide supporting documents. If provided to you, upload the previous owner's boat registration card.
