I am in receipt of your letter of August 16, 2019 concerning your desire to remove certain properties, owned by Tollers Ferry Lakeside Holdings, LLC from the mandatory water and sewer connection requirements of MLW&S. The parcels in question are as follows: 244-1-A; 244-A-7A,8,9; 250-A-2; 251-A-1,2C.

After careful consideration, MLW&S grants your request and hereby removes the subject parcels from the mandatory water and sewer connections as required by its tariff. Please note however that this action does not release said parcels from future compliance with the Bedford County Subdivision Ordinance's waterline extension requirements. In addition, if BRWA extends a waterline at some point in the future, any parcels which are directly adjacent to that waterline, and which develop after the installation of said waterline, will be subject to the BRWA's Mandatory Connection policy. While this action removes the requirement for MLW&S, or its assigns, to provide service to these parcels, this action does not prohibit the owner of these parcels, or its assigns, from requesting future connection to the water and/or sewer system subject to approval by the operator of those systems.

I hope that this meets your needs. I wish you luck as your plans for this property move forward.

SUPPLEMENTAL DECLARATION TO MARINERS LANDING MASTER COVENANTS DECLARATION OF RIGHTS, RESTRICTIONS, AFFIRMATIVE OBLIGATIONS AND CONDITIONS

ARTICLE ONE

WHEREAS, the Declarant has certain powers pursuant to said Covenants, including, pursuant to "Part IX – ANNEXATION" of said Covenants, the authority to unilaterally remove land from Mariners Landing by filing a supplemental Declaration in the said Clerk's Office; and

WHEREAS, the owner of certain properties, identified as Tax Parcels 244-1-A, 244-A-7A, 244-A-8, 244-A-9, 250-A-2, 251-A-1, and 251-A-2C and as more fully described in Instrument Number 140010179 recorded in the Clerk's Office and shown upon a plat therein recorded in Plat Book 56 Pages 322, 323, 324, 325, and 326, has requested that the Declarant remove said properties from Mariners Landing and the Mariners Landing Master Covenants; and

WHEREAS, the Declarant is in agreement with this request;

Now, THEREFORE, pursuant to Part IX of the Mariners Landing Master Covenants, as amended, the Declarant hereby removes the land described below from Mariners Landing, the Mariners Landing Master Covenants, and any requirements thereunder. This instrument shall have no effect upon the Master Plan of Mariners Landing or upon the land hereby removed from Mariners Landing and the Covenants, as to such Master Plan.
