That for and in consideration of the sum of Ten Dollars (\$10.00), and other valuable consideration, the receipt of all of which is hereby acknowledged by the party of the first part, the said ALINE S. TRIMBLE, widow, does hereby grant, bargain, sell and convey, WITH GENERAL WARRANTY and ENGLISH COVENANTS OF TITLE, unto the said ROBERT B. HELMICK and JUDITH M. HELMICK, jointly as tenants by the entireties with the right of survivorship as at common law, the following described real estate, to-wit:

All that certain tract or parcel of land, together with all improvements thereon and all appurtenances thereunto belonging, situate in Beverley Manor District of Augusta County, Virginia, more particularly described as Tract 3 on the Plat of Division of Property of the James A. Trimble Estate and a Portion of the Glenn E. Yount Estate, said plat dated July 17, 1975, made by J. W. Harris, C.L.S., a copy of which plat is to be recorded with this deed and whereon said Tract 3 is described in metes and bounds as: Beginning at a point in the east right of way line of the C. & W. Railroad and the center of Poague Run, a corner to Bonfoey, thence with Bonfoey down the center of Poague Run S 44° 40' 40" E 103.90 ft. to a point in the center, thence S 82° 32° 50" E 99.96 ft. to a point in the center, thence S 67° 08' 45" E 207.31 ft, to a point in the center of said stream, a corner to Tract 4 of the Glenn E. The conveyance is made expressly subject to an easement or right-of-way for ingress and egress from U. S. Route 11, through the C. & W. Railroad underpass, across said tract, serving property owned by the Glenn E. Yount Estate and property owned by Moore, which easement shall be a covenant that shall run with the land, and binding upon the heirs, successors or assigns of the parties of the second part.

Specifically included with this conveyance as an appurtenant right thereto is an easement or right-of-way for ingress and egress over the roadway leading from U. S. Route 11 through the C. & W. Railroad underpass to the property herein conveyed which roadway is shown on the attached plat to be a 30 foot lane.


