- MERCHANDISE:** All merchandise to be sold to the highest bidder(s) for cash at the fall of the hammer. - TAXES:** Sales tax (7%) will be charged in accordance with state laws. Dealers must provide current Certificate of Resale and Dealer in Motor Vehicle License.
- DEPOSITS:** A twenty-five percent (25%) deposit must be paid on all vehicles purchased if one must leave the Auction. **Deposit minimums are established at the Auctioneer's discretion. If the Auctioneer deems necessary, deposits may be called for at any time any item is sold.** All deposits to be made in cash or cashier's check made payable to **FISHER AUCTION COMPANY.**
