- 5. TAXES:** Sales tax (7%) will be charged in accordance with state laws. Dealers must provide current Certificate of Resale and Dealer in Motor Vehicle License.
- 6. DEPOSITS:** A twenty-five percent (25%) deposit must be paid on all vehicles purchased if one must leave the Auction. **Deposit minimums are established at the Auctioneer's discretion.
