4.) Above mentioned client has inspected subject property and agrees to purchase subject property in "AS-IS" condition.

5.) Broker will not receive a fee without the client's signature on the Broker Registration Form.

6.) Broker's commission will be paid from the Fortna Auctioneers escrow account no later than 10 business days from the settlement date on subject property.

Any prospective bidder/buyer that has previously been in contact with Fortna Auctioneers or the seller concerning the subject property will NOT be eligible as a client for any Broker or Salesperson. If prospective bidder/buyer contacts Fortna Auctioneers or the seller prior to our receipt of the Broker Participation form OR if the buyer/bidder is the Broker/Realtor OR if the prospective buyer/bidder is a neighbor to the seller OR if prospective buyer/bidder has received auction information from Fortna Auctioneers, the Broker/Realtor will NOT qualify for a commission. BUYER MUST HAVE BEEN INTRODUCED TO THE REAL ESTATE AUCTION SOLELY BY THE BROKER/REALTOR.
