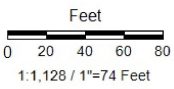
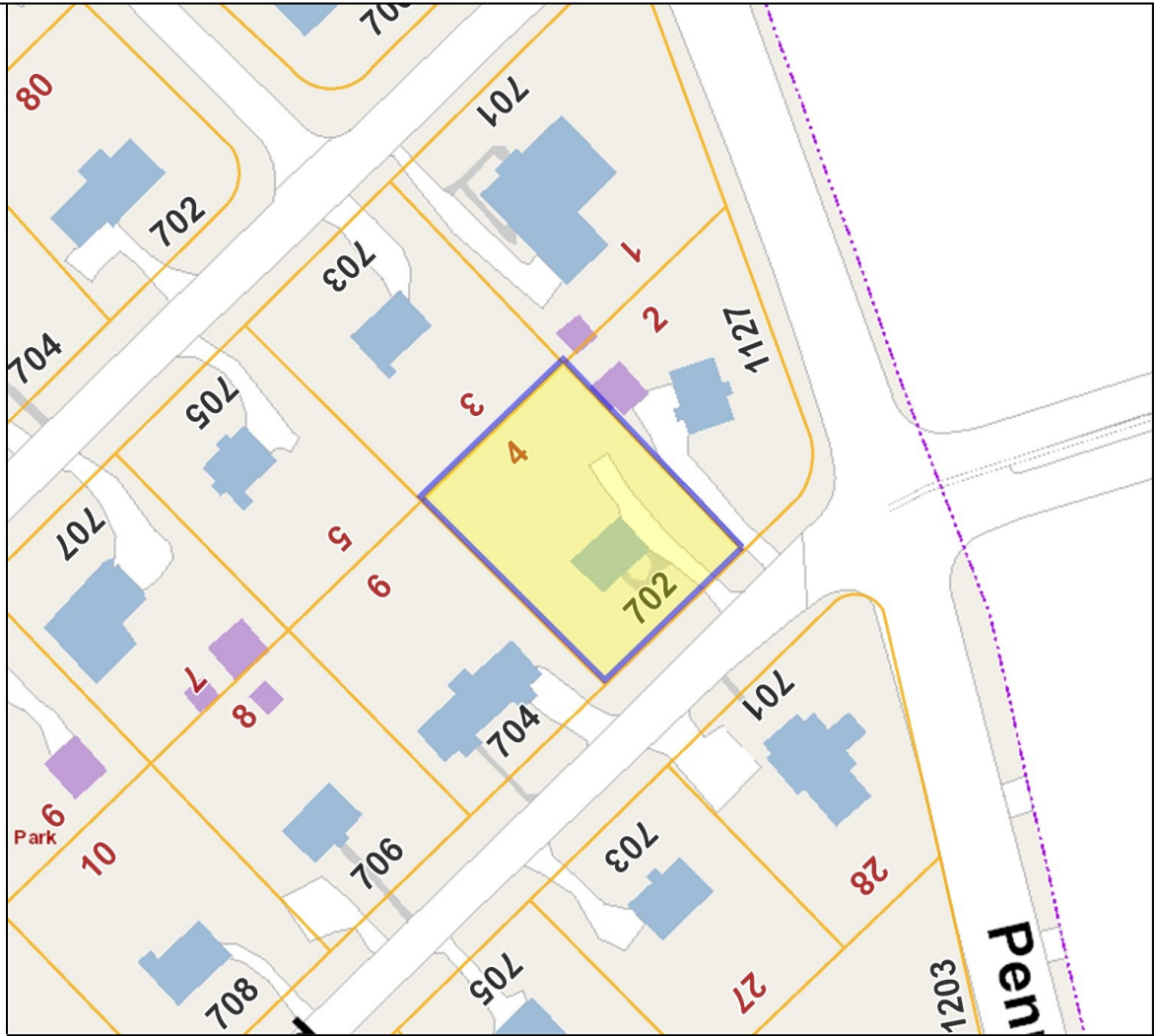
Taxes due December 5th relate to July through December.
