-TITLED ITEMS: All titles must be lien free, titled in the consignee's name, along with consignee's signature at the time of filling out this contract.

-The seller is responsible for providing proof of all liens. If unable to provide proof, the auctioneer will order a UCC check, at the expense of the seller.  
 -During the auction, the auctioneer will represent the condition of consigned items as stated to him by the seller. In the event a purchaser is dissatisfied with said representation of condition,

or finds it misstated, seller will do one of three things: 1. Repair the unit for purchaser. 2. Allow the auctioneer to resell it on the spot or at the next available auction. 3. Take the unit back and refund the sale price.

-The seller will indemnify, save & hold harmless the auctioneer from & against any & all claims, damages, liabilities obligations, costs & expenses (including court costs & attorney fees) incurred by the auctioneer in connection with or arising out of the failure of seller to observe or perform any obligation under his agreement or any agreement executed in connection herewith. ALL VEHICLES ARRIVING AT THE SALE SITE, WITHOUT A TITLE, WILL BE PLACED ON HOLD & WILL NOT BE PUT INTO THE AUCTION UNTIL THE TITLE IS ON SITE. In the event an action arises between the seller & the auctioneer, the action will be settled through mediation under Wisconsin Law.

-Sellers are responsible for holding their own insurance on items until the item(s) have sold. Auctioneer shall not be held responsible for any loss or damage to the equipment. If the buyer defaults on payment, the seller still owns the equipment.

-Unsold items that are not picked up by the end of the drop off for the next month's consignment may be sold on the next month's consignment without a reserve. If still unsold, item(s) need to be picked up by the end of auction date or all item(s) go into Hansen & Young possession.

-This agreement is not subject to cancellation without the written agreement of both parties.
