

Monroe Township, Johnson County, IA










SOIL MAP

Land Description

The farm is gently rolling.

Drainage

Drainage is natural with some tile. Tile maps are not available.

House

There is a one-story house with 1,692 finished square feet of living space. The west portion of the home was built from a remodeled mobile home and includes two bedrooms, two bathrooms, living room and kitchen with cherry cabinets. The addition to the east includes a large living room with a wood-burning fireplace featuring a limestone surround and a laundry room. A nice screened-in porch has been added to the back of the house. Below the addition there is a lower level with a wood shop, forced-air furnace/air conditioner, water heater, pressure tank, water softener, and breaker box.

East of the home is a 22' x 42' aboveground pool surrounded by a raised wooden deck.

There is a two-stall detached garage that was built in 1989.

Outbuildings

There is a $3\overline{2}' \times 63'$ steel utility building that was built in 1992. The south portion has a concrete floor, is insulated and has a heater.

Water & Well Information

The well is south of the house.

LP Tank

The 1,000-gallon LP tank is currently rented from Kerkove.

Septic System

The septic system is located north of the house. The septic system was updated with new absorptions lines in 2007.

Comments

An attractive farm and home located along a hard-surfaced road west of Swisher. Property includes an estimated 55.89 acres of productive cropland, a large outbuilding, asphalt driveway, and nice landscaping. The balance of the farm is mature timber and a creek.










Northeast of House with Screened Porch








ASSESSOR MAP
