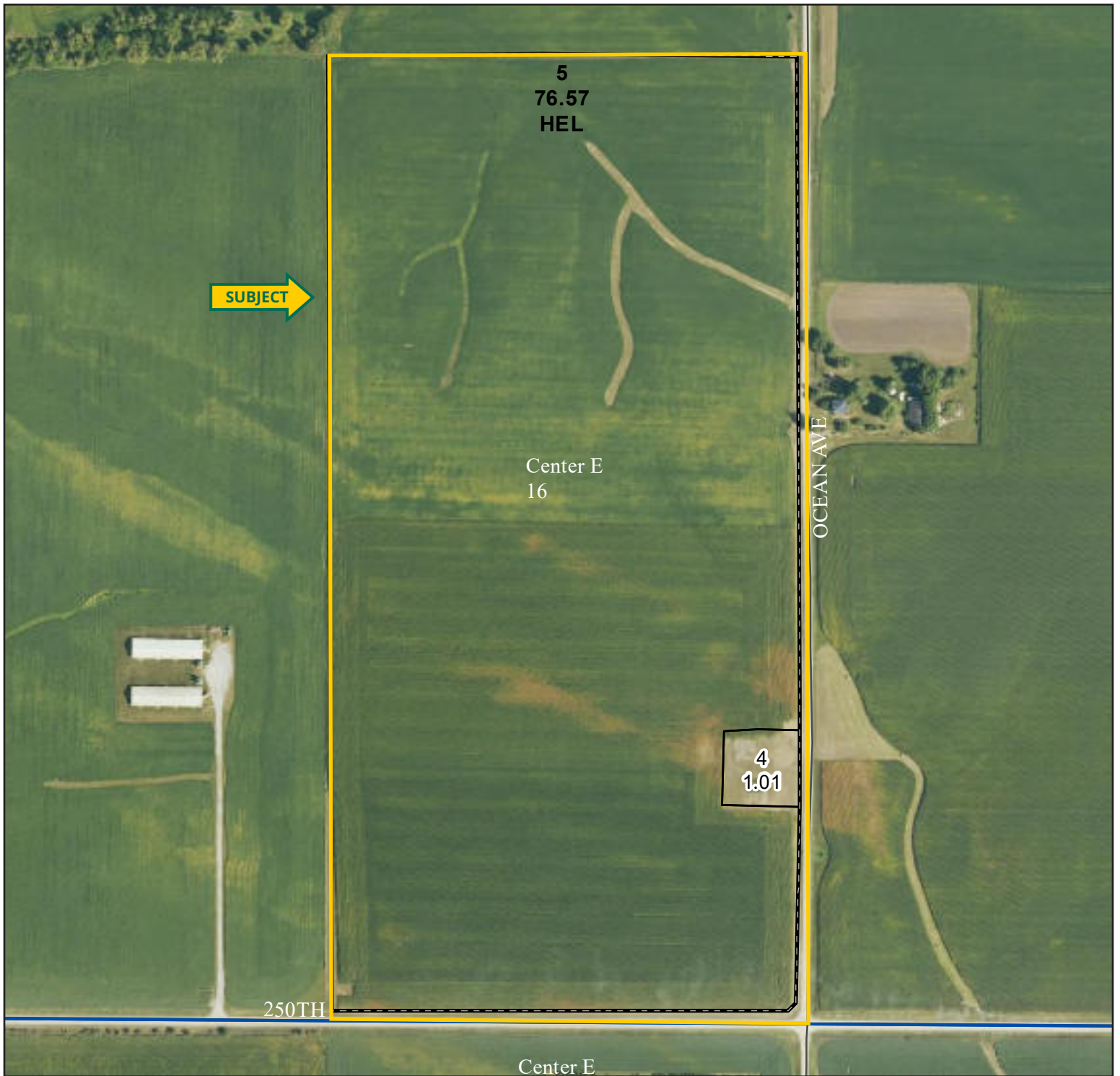

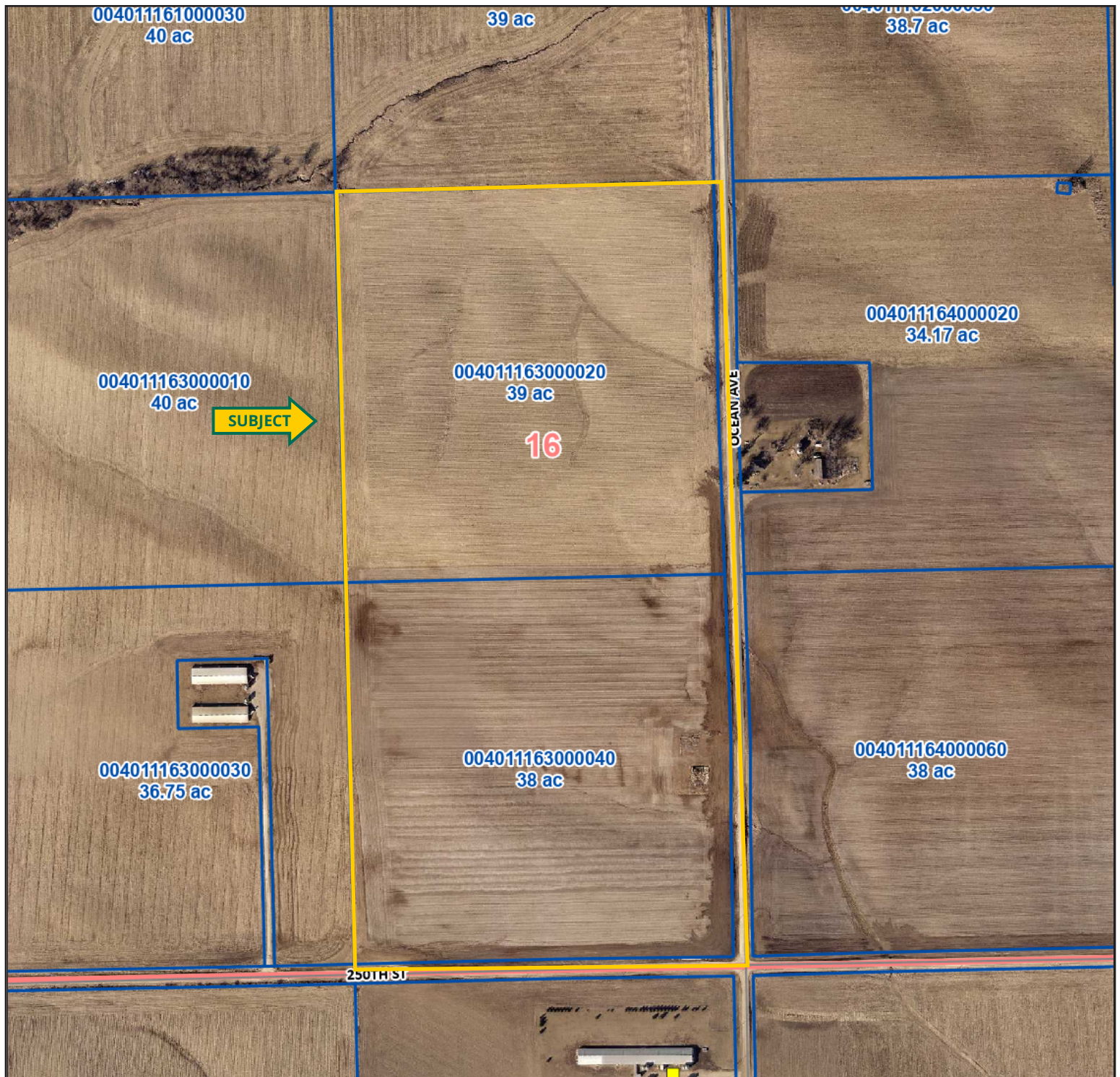
Northeast Corner Looking Southwest



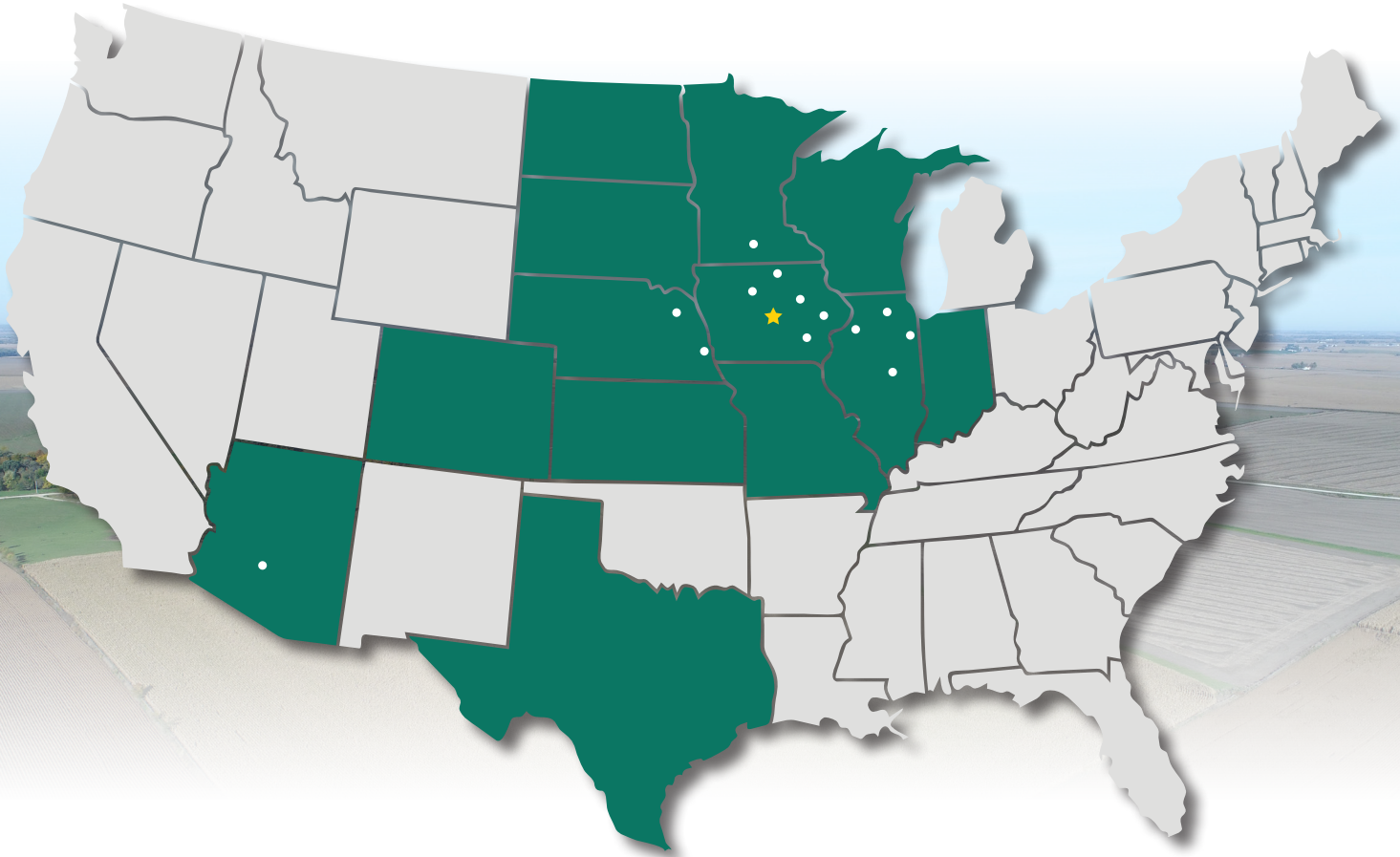
Southeast Corner Looking Northwest
