DEED RECORD

AMENDMENT OF RESTRICTIONS
MELSHIRE ESTATES ADDITION, FOURTH INSTALLMENT

WHEREAS, on January 28, 1961 NORTHTOWN, INCORPORATED did execute and place of record a certain set of restrictive covenants affecting the following described property situated in MELSHIRE ESTATES ADDITION, FOURTH INSTALLMENT, an Addition to the City of Dallas, Texas, according to the Map thereof recorded in vl. 44, page 39, Map Records, Dallas County, Texas, to-wit:

- Lots 1 through 8 inclusive in Block 2/6380
- Lots 1 through 14 inclusive in Block 3/6380
- Lots 1 through 15 inclusive in Block 1/6380
- Lots 1 through 13 inclusive in Block 4/6380
- Lots 1 through 12 inclusive in Block 5/6380
- Lots 1 through 14 inclusive in Block 6/6380
- Lots 1 through 8 inclusive in Block 7/6380 and
- Lots 13 through 20 inclusive in Block 7/6380,

which restrictive covenants appear of record in volume 5490 at page 80 of the Deed Records, Dallas County, Texas; and

WHEREAS, under numbered paragraph 1. said restrictive covenants provided as follows:

"1. All of the lots in this tract shall be known as and described as residential lots and no structure shall be erected other than single family dwellings and in no event to exceed one and one-half stories in height, except Lots 1 through 15 inclusive, Block 1/6380, upon which lots at purchaser's option, may be erected two-family (duplex) dwellings, in no event to exceed two stories in height," and

WHEREAS, it is now desired that said restrictive covenants be amended insofar as lots 7 through 14 inclusive in Block 6/6380 are concerned to provide that said lots 7 through 14 inclusive in Block 6/6380 may be used as church property with full right to construct thereon a place of worship and the necessary educational buildings and parking facilities to be used in connection therewith; and

WHEREAS, the undersigned are the owners of all property situated in MELSHIRE ESTATES ADDITION, FOURTH INSTALLMENT affected by the restrictive covenants,

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS: For and in consideration of the benefits to accrue we the undersigned do hereby consent to the amendment of said restrictions and by this instrument do amend the restrictions so that paragraph 1. thereof shall read as follows:

1. All of the lots in this tract shall be known as and described as residential lots and no structure shall be erected other than single family dwellings and in no event to exceed one and one-half stories in height, except Lots 1 through 15 inclusive, Block 1/6380, upon which Lots at purchaser's option, may be erected two-family (duplex) dwellings, in no event to exceed two stories in height, except Lots 7 through 14 in Block 6/6380 which may be used for church purposes.

All other terms and conditions of said restrictive covenants shall remain the same under full force and effect as provided therein.
