## **Broker Participation Requirements:**

2. Professionally assist your client by providing relevant advice and property information.

4. Attend the auction with your client. Your Client will register to bid at the auction. Please provide a business card to attach to your client's registration form.
5. If your Client is the high bidder, you will escort them to the Contract Room after their purchase to assist them with questions regarding the contract and sign the contract as Agent.

If any of these steps have been omitted, the broker will not be paid a commission. There will be NO EXCEP-TIONS. Bidders will be required to acknowledge Buyer-Broker relationship as they register at the sale. By bidding, each Bidder and Buyer Broker agree to indemnify and hold harmless Seller and Auctioneer for any and all claims for compensation made by any other person or entity in connection with the auction.
