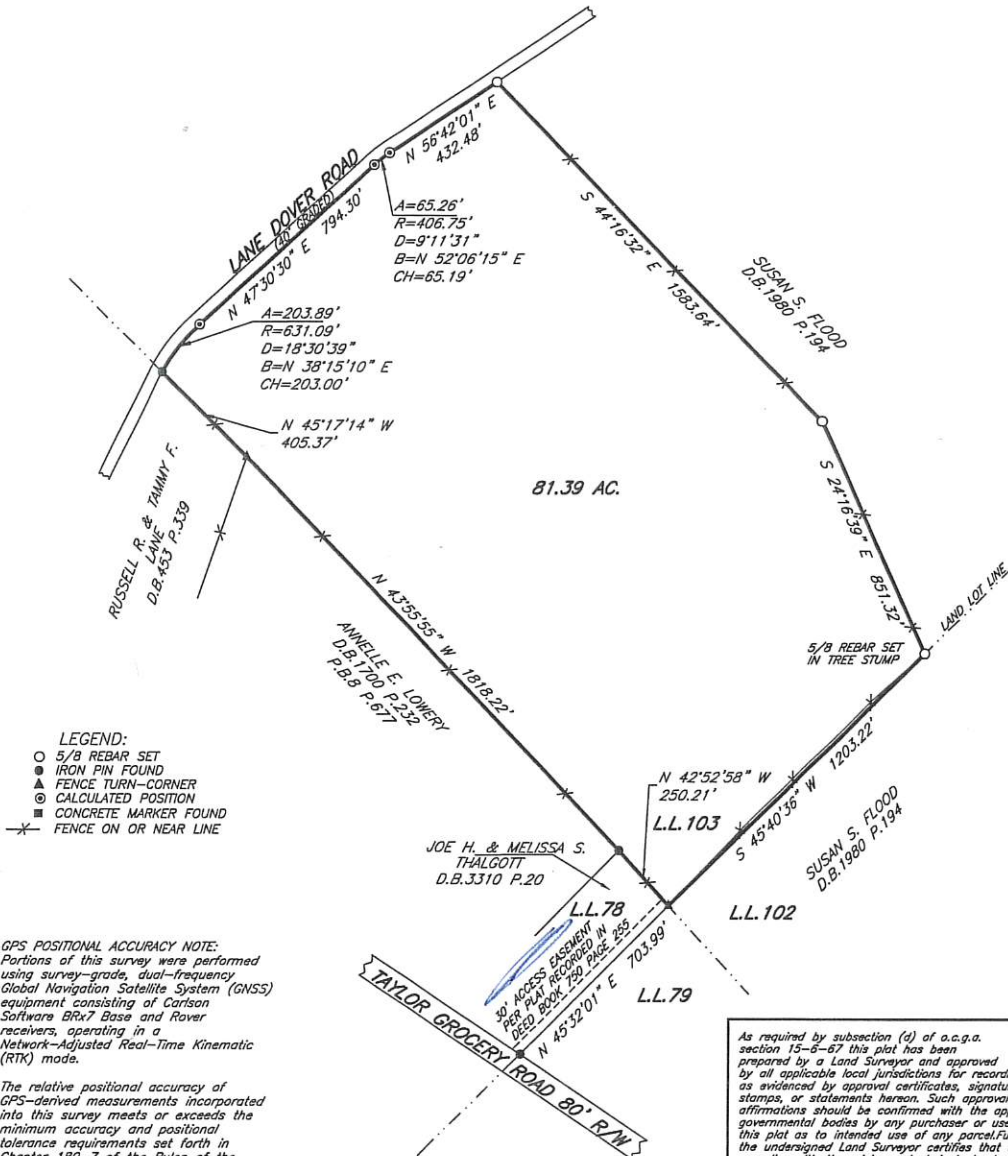

 Portions of this survey were performed using survey-grade, dual-frequency Global Navigation Satellite System (GNSS) equipment consisting of Carlson Software BRX7 Base and Rover receivers, operating in a Network-Adjusted Real-Time Kinematic (RTK) mode.

The relative positional accuracy of GPS-derived measurements incorporated into this survey meets or exceeds the minimum accuracy and positional tolerance requirements set forth in Chapter 180-7 of the Rules of the Georgia Board of Registration for Professional Engineers and Land Surveyors, based upon field verification, redundant observations, and integration with conventional surveying methods.

All boundary positions shown hereon conform to the applicable accuracy standards for the classification of land surveyed.
