### **THE PROPERTY HEREIN DESCRIBED IS BEING SOLD IN "AS IS" CONDITION WITHOUT WARRANTY OF ANY KIND. THIS INCLUDES ANY WELL AND/OR SEPTIC SYSTEMS.**
