

**MARCKA AUTO AUCTION
PUBLIC AUTOMOBILE AUCTION RULES & PROCEDURES
PUBLIC PURCHASE DETAILS:**

All buyers must pre-register in the office prior to bidding. You are required to be 18 years of age or older and have a driver's license as identification for bidder registration (this is also the name the vehicle will be titled in). Upon payment of deposit in the amount of \$300.00, you will be issued a bid number, which must be worn so it is visible to the auctioneer. The deposit will be credited to your auto purchase.

If you don't buy a vehicle, the \$300.00 deposit will be refunded to you. For refund you must return your bid number and receipt to the office. You may inspect the vehicles on sale day before they are auctioned. No test drives are allowed. Please base your bid on this inspection. You may bring your mechanic to our lot to inspect your vehicle choices before they are auctioned. Each vehicle is sold "AS IS, WHERE IS". All sales are FINAL! Any person found tampering with or removing equipment from vehicles will be subject to suspension from the sale and possible prosecution.

When a car comes to the auction block bidding begins so listen carefully to the auctioneer for all announcements. You will be held financially responsible for any bids tendered. Make sure you know what you are bidding on. Raise your hand to bid, making sure the auctioneer recognizes your bid. Once the auctioneer announces that the vehicle is sold to you, you are the purchaser. Buyer agrees that all sales are final! Buyer agrees and states that he is buying vehicle described herein from

Seller for the purchase price shown, has verified the VIN number on the vehicle, inspected the actual condition of the vehicle, verified whether vehicle's odometer is properly functioning and conforms to information appearing on mileage verification statement and all other transfer documents, examined all titles and transfer documents and has determined that no discrepancies exist and that Seller's documents are acceptable to him.

Buyer and Seller agree that Marcka Auto Auction processes titles and other documents as convenience to Buyer and Seller. It is agreed that Marcka Auto Auction shall not be responsible for the contents of said documents. Marcka Auto Auction makes no representation, guarantee or warranty, and assumes no responsibility regarding mileage of any vehicle sold by Seller or purchased by any Buyer at Marcka Auto Auction.

Marcka Auto Auction is not responsible for theft of vehicles, collision, mechanical damage, personal injury or personal property loss of any type occurring on Marcka Auto Auction property. Marcka Auto Auction will not be responsible for accidents of any kind. All vehicles purchased or sold on Marcka Auto Auction property must be processed and paid for through Marcka Auto Auction office. All titles and payments must pass through the office for processing.

Buyer is responsible for verifying VIN number on auction invoice and ownership papers being transferred to his name against such actual number on vehicle. No vehicle can be offered for sale without serial number plate. All vehicles are subject to examination by law enforcement officers and Marcka Auto Auction designated personnel.

BIDDING

A car will come to the auction block. The car may be running, with doors and hood open for inspection. The highest bidder buys the car. Most sales are subject to a reserve bid, which means there is a minimum price the auctioneer can accept. All sales are FINAL! All sales are "AS IS, WHERE IS". Remember, you must be 18 years of age or older to register for a bidder number. You must register in the office to receive a bidder's number in order to bid.

ACCEPTING THE BID

You will be required to turn over your bidder number to our staff. You will then be escorted to the office to complete the transaction. Once in the office, our staff will execute the necessary paperwork. Check the accuracy of your documents before signing. No vehicle can be removed from auction grounds until paid in full. Full payment for vehicle includes vehicle purchase price, buyer's fee, and TN sales tax.

SELLING YOUR VEHICLE

You must have a clear title, in your name. Picture ID will be required. If the seller is not the titled owner, the seller must have a notarized power of attorney before the vehicle can be sold at the auction. Titles with the following defects will not be accepted: documents not authorized, jumping signatures, alterations, erasures, wrong digits, improper re-assignments, missing forms, mileage problems. Vehicles must be on property to be assigned a number. Please remove all personal effects from your vehicle, as the auction is not responsible for these items.

If your vehicle sells, a sell fee will be deducted from your proceeds check. If anyone wishes to re-run a vehicle that didn't sell, they may run it a second time after all first runs are run through, for that night only.

When your vehicle comes up to the auction block, stand by the auctioneer and tell him what price you want for the vehicle. Be honest: the auctioneer is there to sell your car! Seller should represent item truthfully and honestly to bidder and buyers. Seller warrants and covenants with Buyer that he has absolute title to and is the true and legal owner of the vehicle described herein; that vehicle is free from all liens; that he has the right and power to sell and transfer title to vehicle; and that he will defend the same against all claims.

Seller is responsible for representing that the mileage reading on his vehicle is accurate, or disclosing that the odometer reading is incorrect. It is the Seller's responsibility to verify the actual mileage. Marcka Auto Auction assumes no responsibility, nor guarantees the accuracy of the odometer reading. Marcka Auto Auction does not guarantee year, model, or odometer. Seller is responsible to insure the correct year, model, and odometer information written on vehicle is correct. Previous salvage or insurance titles must be announced. Frame damage must be announced.

After the last bid is received, the auctioneer will confirm the highest bid with you. You have the right to accept or reject the bid. If you accept it, the vehicle is SOLD and you cannot change your mind.

Seller will not receive funds until Marcka Auto Auction has received funds from buyer.

ADDITIONAL INFORMATION

Marcka Auto Auction reserves the right to refuse service to anyone. Due to insurance policies, no one under the age of 16 allowed during sale. In disputes of any nature regarding the sale or purchase of vehicles at Marcka Auto Auction, the decision of Marcka Auto Auction shall be final and binding on all parties.

A copy of Marcka Auto Auction Rules and policies are posted at the Auction and copies are available in the office.

Copies of buyer/seller fees are also posted and copies are available in the office.

Frame damage must be reported to the Auction within 72 hours and inspected by the Auction.

Marcka Auto Auction will not be responsible for vehicles left on premises or for any personal property left in vehicles.

Marcka Auto Auction will not be responsible for any levels of fluids or liquids in any type of units such as antifreeze, oil, gasoline, or differential lubes. It is the buyer or seller's responsibility to check these items on the vehicles.
