I, the undersigned, agree to the following terms and conditions, should I be the high bidder.

Auction Day Requirements:

- 1. All bidders must be pre-registered.** A \$50,000 deposit must be placed into Max Spann Real Estate & Auction Co. escrow account by 5PM on Wednesday, October 14, 2026. Auction Co. may not approve a bidder if notification of bank transfers or deposits is received after the time frames prescribed. Auctioneer reserves the right to add or delete property from this auction or to alter the order of sale from that published herein. - 6.** Bidder and Bidder's heirs, transferees, administrators, personal representatives, trustees, successors and assigns, forever waive, release, discharge and hold Spann harmless, from any claim it has, might have had, or may have against Spann with respect to:
 - a. The condition of the Premises, either patent or latent, of any nature whatsoever, including environmental contamination;
 - b. Buyer's ability or inability to obtain or maintain building permits, temporary or final certificates of occupancy or other licenses for the use or operation of the Premises, and/or certificates of compliance for the Premises;

d. No Reverse Engineering or Contact. Bidder shall not contact Starbucks Corporation, any Starbucks affiliate, or any Starbucks store representative directly regarding the Premises or the information contained in the PIP without the prior written consent of Seller. Bidder shall not attempt to verify, reverse-engineer, or independently derive any Starbucks Confidential Information through direct outreach to Starbucks.

e. Remedies. Bidder acknowledges that any breach of this Section 7 would cause Seller irreparable harm for which monetary damages would be an inadequate remedy, and that Seller shall be entitled to seek equitable relief, including injunction and specific performance, in addition to all other remedies available at law or in equity, without the necessity of posting a bond or other security.

f. Survival. The obligations set forth in this Section 7 shall survive the auction date and any termination or expiration of this Bidder Registration Agreement, regardless of whether Bidder completes a purchase of the Premises.
