Guarantee: Included in the original treatment is a re-treatment guarantee. The terms and conditions of the guarantee are as follows. Mac's Exterminating does promise to reinspect the structure on or before the renewal date at the owners request. Mac's may initiate the inspection but it is the homeowner's responsibility to request the inspection. If there is any infestation or reinfestation (of the specific organism or moisture problems treated for and listed below), on or before the renewal date, then Mac's Exterminating does promise to rework the entire structure according to the minimum standards as set forth in the SC Pesticide Control Act at the time infestation or reinfestation is discovered. This work will be at no cost to the owner of the structure.

Any owner has the right to renew the guarantee on a year to year basis for a fee as set forth below. The owner may renew the guarantee for the life of the structure, however, in the fifth year the renewal fee becomes subject to an inflationary increase of not more than 10% of the original renewal fee per year. This guarantee is transferable to any new owner. Any additions to the structure, as is stood at the time of the original treatment, must be treated as Mac's Exterminating sees fit and at the owner's expense. There shall be a grace period of 60 days from the renewal date. If the renewal fee has not been paid before the grace period ends then Mac's Exterminating has no obligation to renew the guarantee, but may do so.

The property described was treated by us for the prevention or control of SUBTERRANEAN TERMITES. The present warranty, subject to all original terms and conditions, will expire on 01-23-2004 and may be renewed initially at \$ 98.00 by the new owner.

Other Stipulations: The structure is a single story vinyl sided home with a bonus room located at 108 Montclair Circle, Morehaven Sub., Hamilton, S.C. (George & Elizabeth Stone) Directions: 178 from Anderson toward Liberty go to Circle M Barbecue before Hwy 88 Right into Morehaven Right Montclair Home on Right

Note: Mac's Exterminating cannot be responsible for staining water that may or may not occur during future wet weather and/or during future interior/exterior leaks. If staining water should be discovered during future inspections, then it will be the homeowners responsibility to alleviate the staining water within a reasonable amount of time (90 days) at the homeowners expense and to Mac's specifications, otherwise this termite guarantee becomes null and void.
