- **3. Effective Date**: The Effective Date is the date the last party signs this Contract.
- **4. Earnest Money:** The Earnest Money shall be deposited into the Real Estate Escrow account of Meares Property Advisors, Incorporated. The Earnest Money is fully earned by Seller as of the Effective Date and will not be returned to Buyer for any reason. The Earnest Money will be applied towards the Total Sales Price at Closing. - **6. Closing Costs and Prorations**: Buyer will pay all closing costs, including but not limited to: attorney fees, deed preparation, deed recording, deed stamps, survey (if required), mortgage fees, or any other fees or expenses required to close the transaction. All prepaid rents, real property taxes, and other public charges assessed or to be assessed for the year in which this transaction is consummated shall be prorated between Seller and Buyer to the date of closing.

In the event any party brings legal action to enforce the terms of this Contract, the prevailing party shall be entitled to recover reasonable legal fees and costs from the non-prevailing party.
- **9. Inspection**: Buyer is fully satisfied that the Property is suitable for Buyer's intended use and that no further inspections of any kind are necessary. Buyer acknowledges its purchase of the property is AS-IS.
- **10. Assigns**: This Contract of Sale shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, executors, administrators, legal representatives, successors and assigns.
- **11. Entire Agreement**: It is understood and agreed that all understandings and agreements heretofore had between the parties are merged into this Contract, which alone fully and completely expresses their agreement.
