SOLID WASTE MANAGEMENT PERMIT

Weaver Landfill, Incorporated is hereby granted permission to operate a Solid Waste Management Facility described below in accordance with the provisions of Title 10, Section 10.271, Code of Virginia 1950, as amended, and regulations of the Department of Waste Management. The permit is valid from the date of issue until revoked or until such time that operational conditions have been modified or that operation has been satisfactorily terminated.

The permitted facility is a sanitary landfill for Industrial Waste and is allowed to handle Asbestos Waste for disposal. The facility is owned and will be operated by the Crippen companies. The site is located on 8.0 acres of land in Lunenburg County, Virginia on Route 724, south of the Town of Victoria. The metes and bounds of the site are as specified on the revised plat dated August 11, 1987, and on file with the Department of Waste Management.

The operation of the solid waste management facility must meet all provisions of the regulations and all conditions herein specified by the Department in accordance with Section 10-280, Title 10, Code of Virginia as amended. The following conditions of the permit are to be met:

- 1. The Permit is issued in accordance with plans and specifications titled, "Operational Plans for Asbestos Landfill", by Thomas S. Weaver and dated February 1985.
- 2. The metes and bounds of the landfill and the revised trench fill plan are in the revisions titled "Weaver Asbestos Landfill" by Draper-Aden Associates, Incorporated and dated August 11, 1987. The method of placement of the asbestos bags is amended by a letter from Donald Nuttall of Draper-Aden Associates, Incorporated, dated October 5, 1987.

3. Any deviations from these plans and specifications shall require written approval from the Department of Waste Management
