## AMENDMENT TO RESTRICTIVE AND PROTECTIVE COVENANTS PERTAINING TO HIGHLAND WOODS SUBDIVISION

Whereas, a declaration of covenants, conditions and restrictions of Highland Woods Subdivision are set out and recorded in Warranty Deed Book 265, page 113, Register's Office of Franklin County, Tennessee, to which reference is herein made, and

Whereas, the undersigned are owners of not less than 75% of the property included in said subdivision, and

Whereas, the restrictions currently provide for a total minimum structure under one roof of a minimum of 1,500 square feet (1,100 minimum floor space plus 400 square foot garage), and

Whereas, the developer of Lot No. 5 is building a 1,900 square foot home on said lot, and in consideration of such structure, is requesting that a detached storage building of the same material and design as the house be allowed in the yard, behind said home, and

Whereas, the undersigned desire to amend the Restrictive and Protective Covenants to allow this variance as to Lot No. 5 only;

Now, therefore, upon execution and recordation of this Amendment, the Restrictive and Protective Covenants of Highland Woods Subdivision shall be amended under its Architectural, Maintenance and Use Restrictions to provide that, as to Lot 5 only, a detached storage building of the same material and design as the residence may be built in the yard behind the house, and shall be a minimum of 190 square feet.
