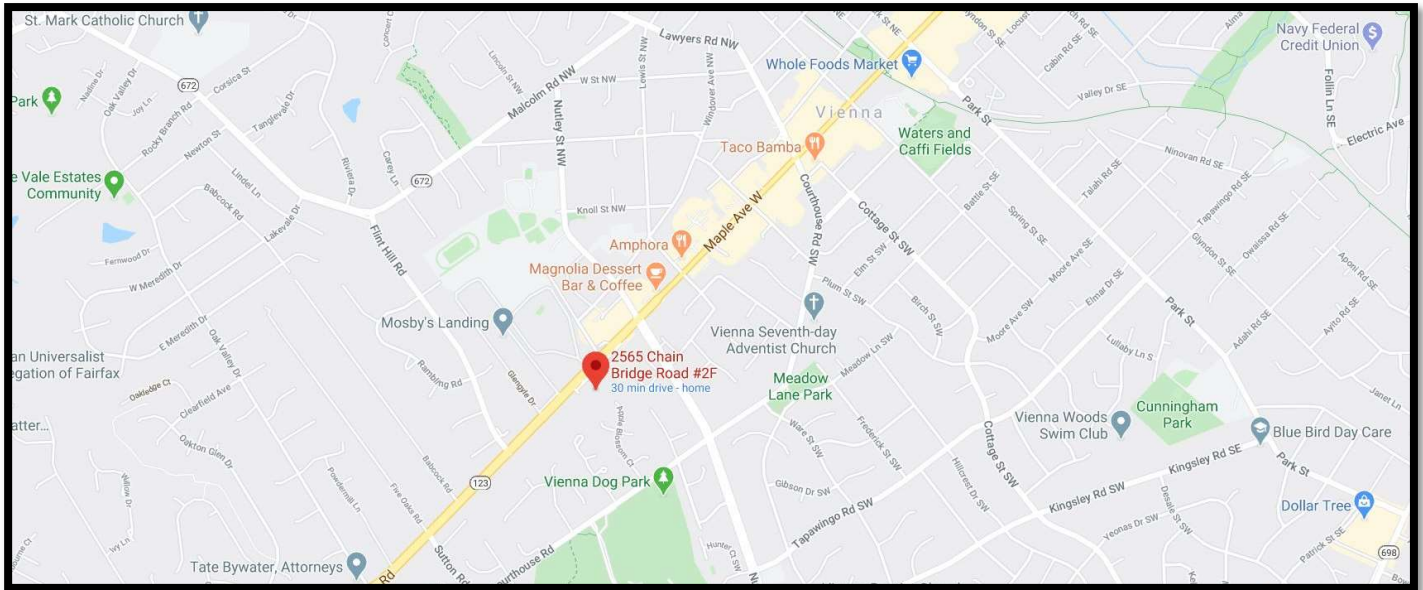
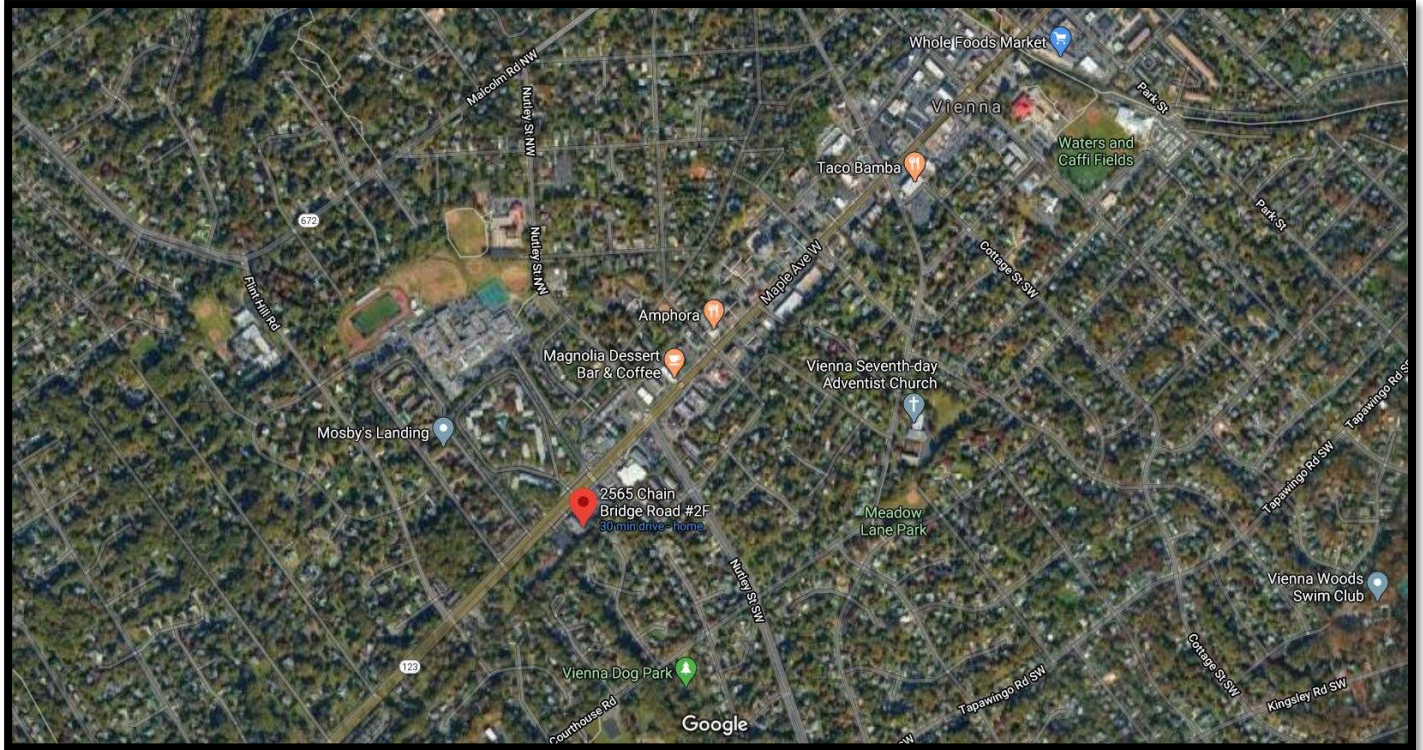

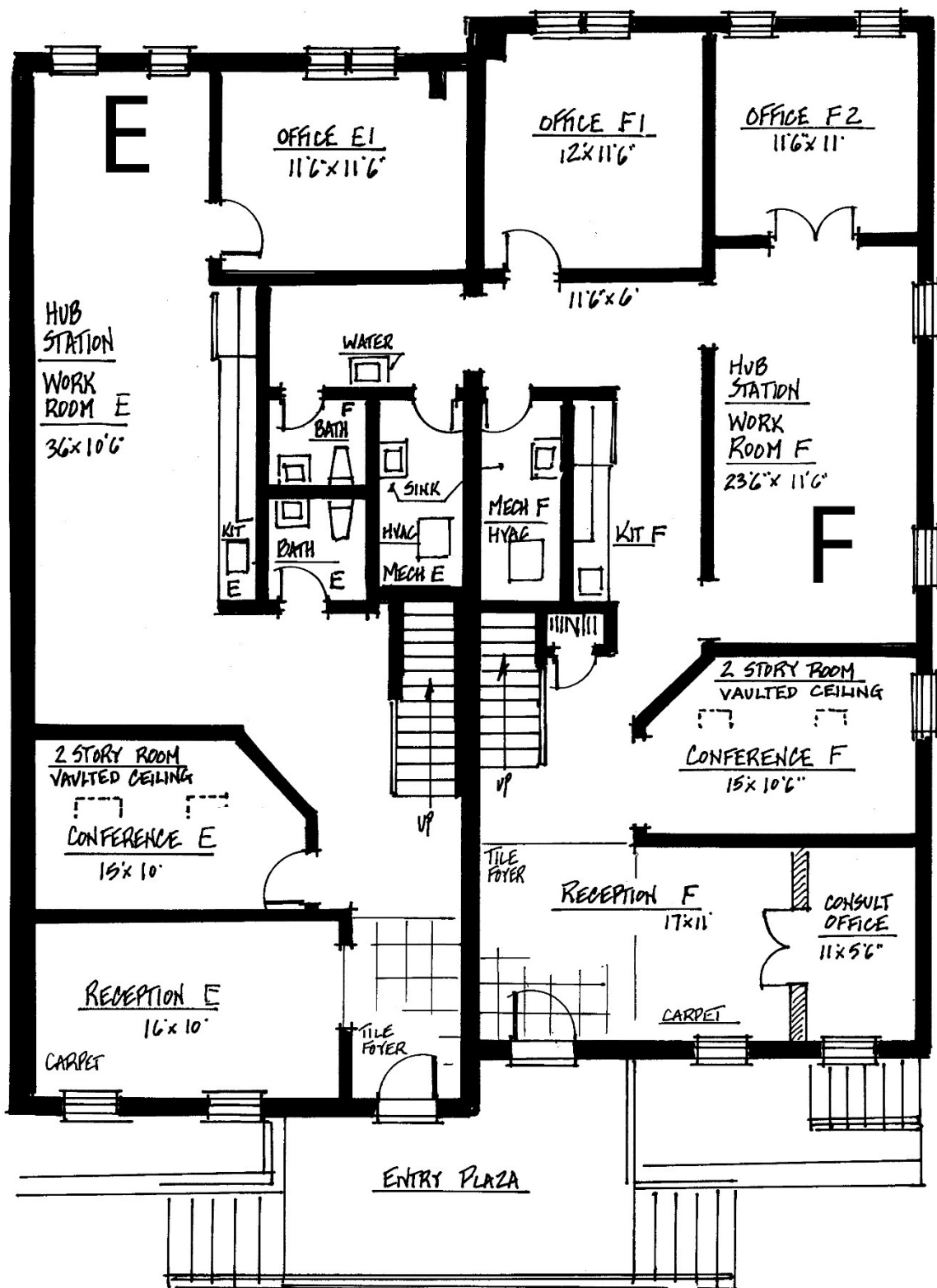


2567 Chain Bridge Rd Unit #2E, Vienna, VA 22181

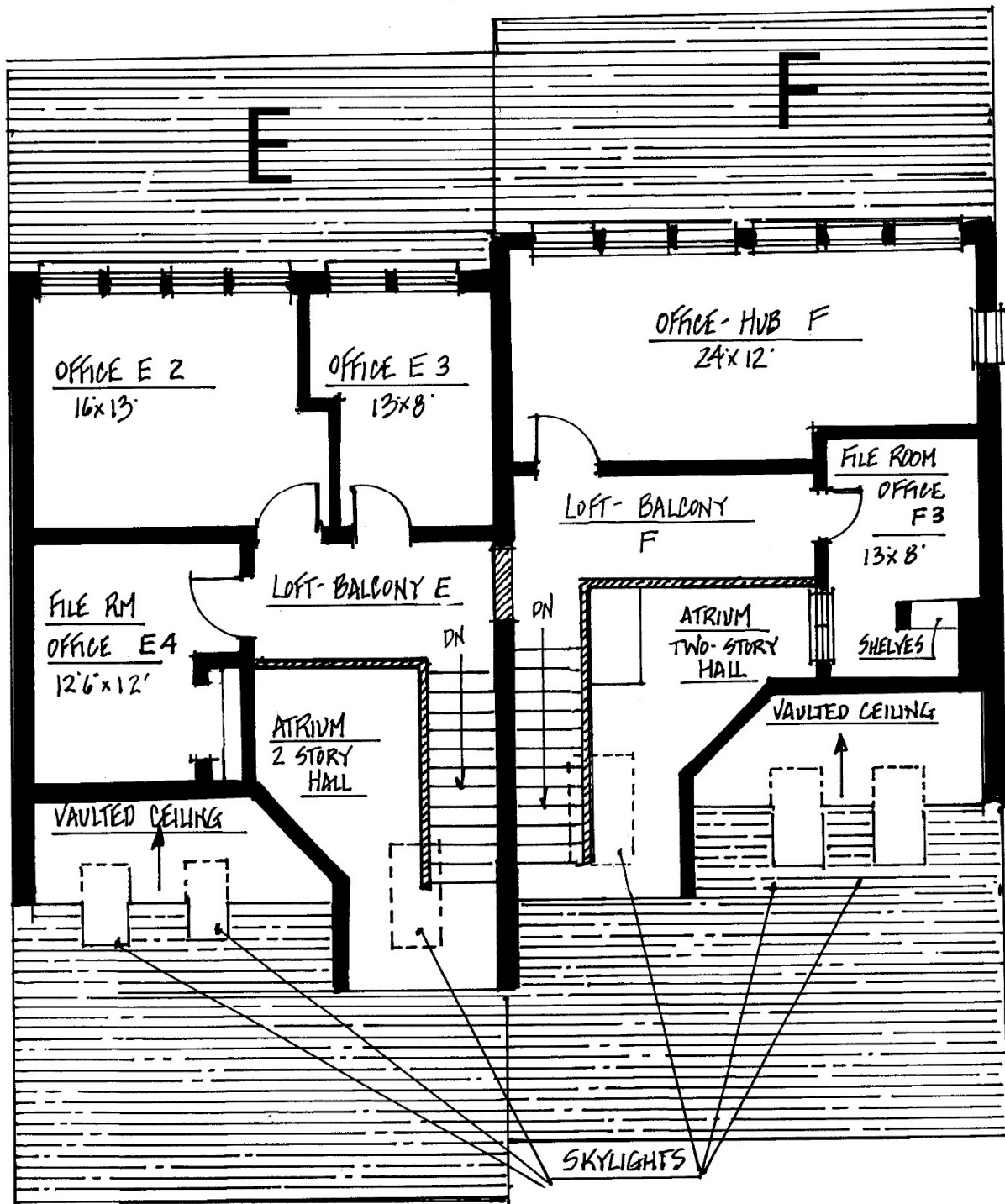

Combined Units Upper Level Floor Plan

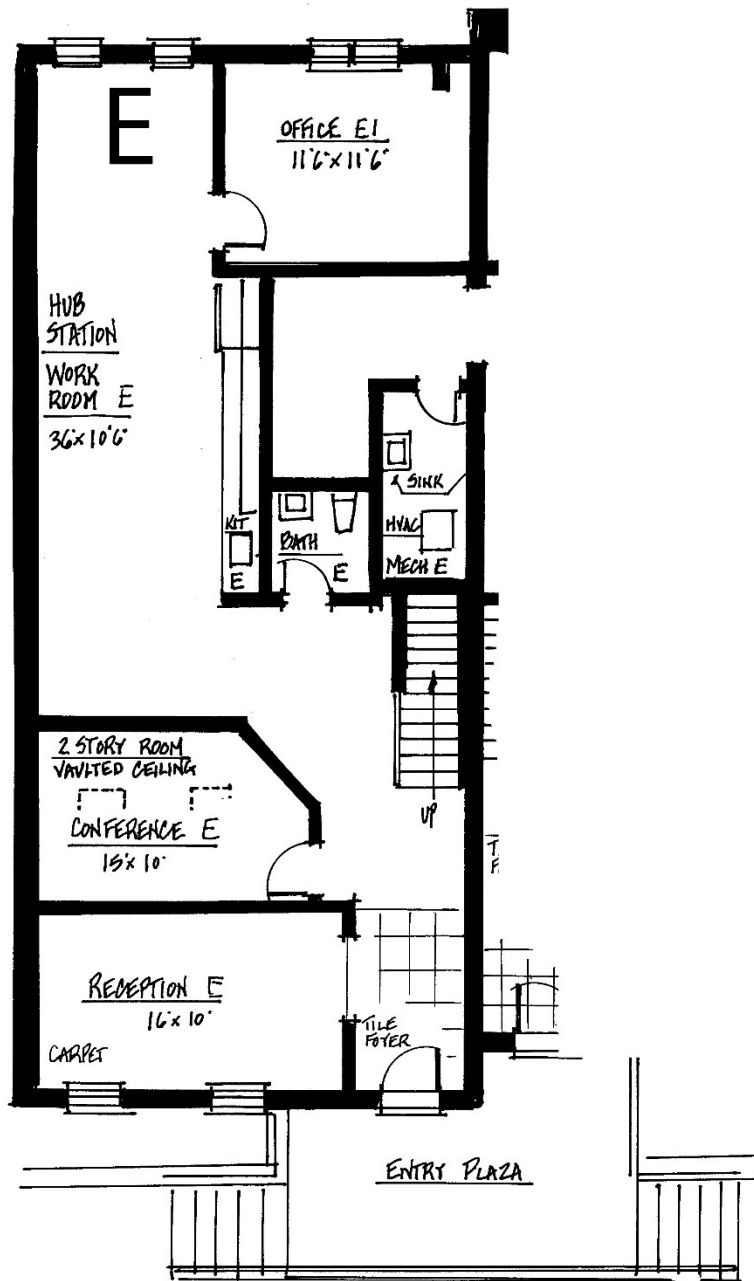

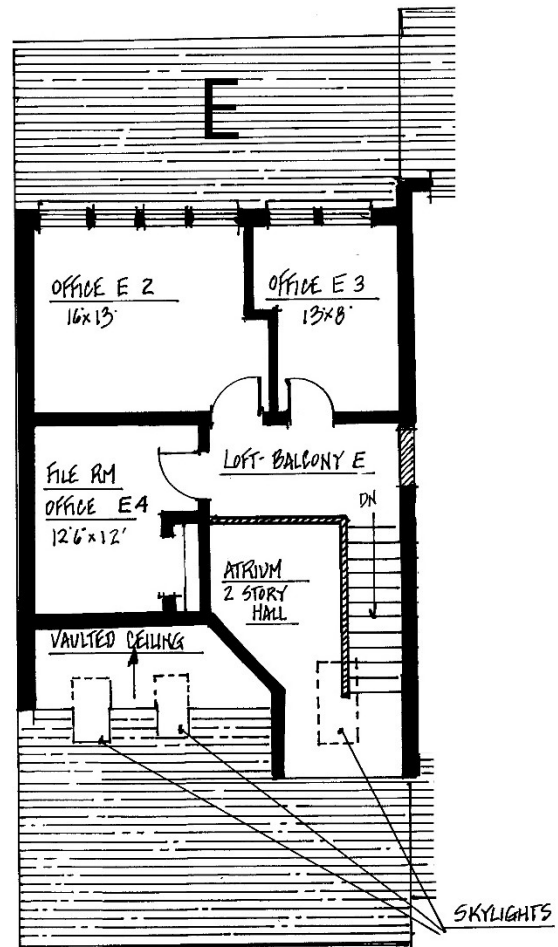

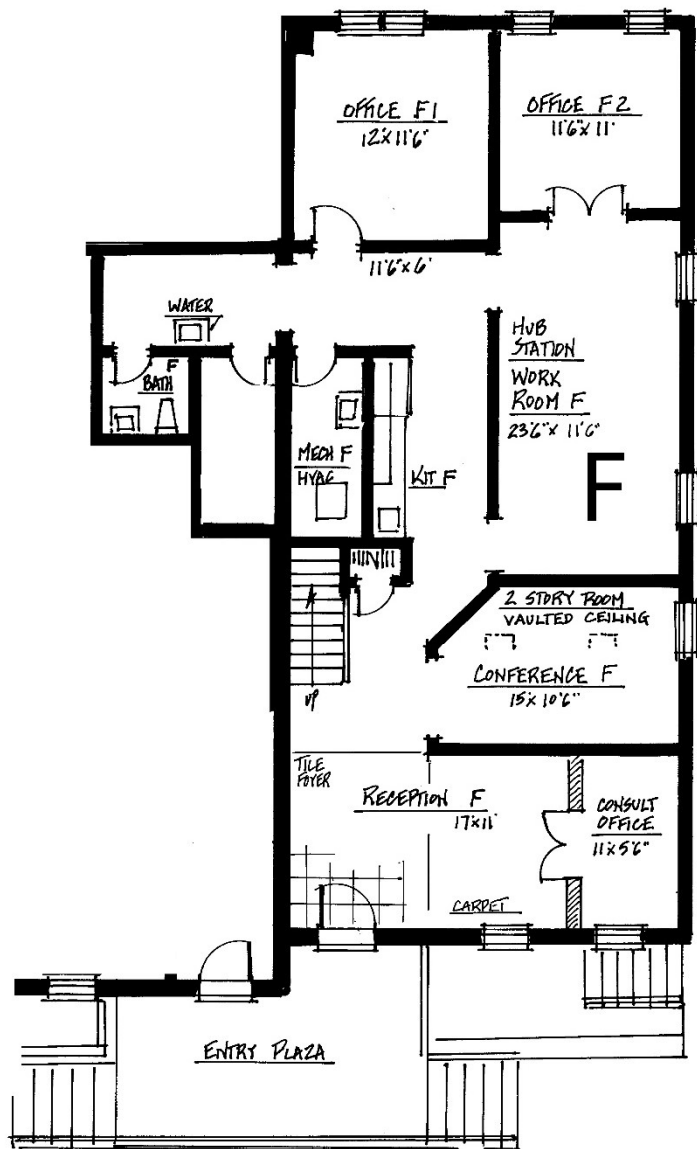

UNIT E UPPER FLOOR

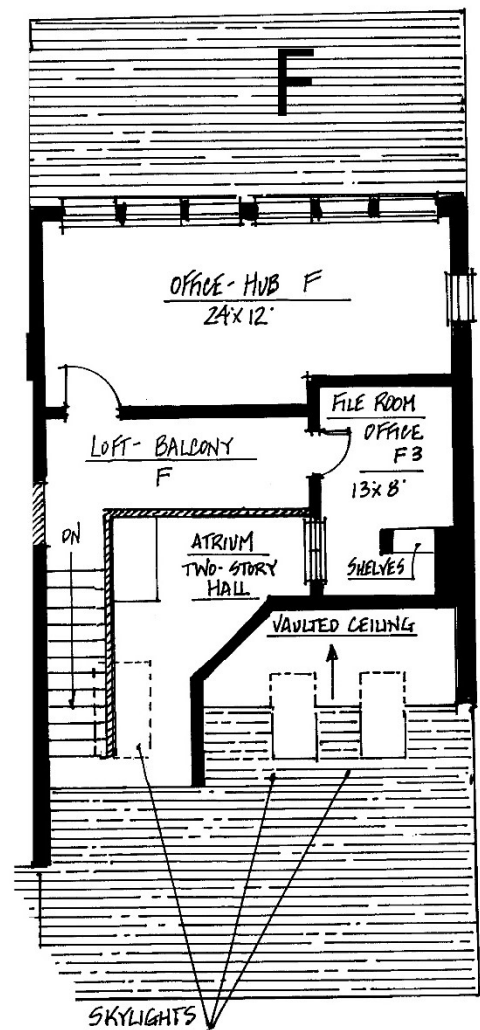
