## **Instructions Regarding Transfer of Firearms**

## **Handgun Purchases:**

- Pursuant to federal law <u>only</u> North Carolina residents may pick up <u>handguns</u> at the premises of the local Winston-Salem Federal Firearm Licensee (FFL) contracted for this auction.
  - Pursuant to North Carolina Law to pick up a handgun, one must have a valid state issued picture ID (Driver's License or ID Card) displaying current address, <u>and</u> one of the two of the following permits:
    - A valid North Carolina Concealed Handgun Permit (with address that matches valid Drivers License or ID card), or
    - A valid North Carolina Handgun Purchase Permit issued by your local NC sheriff.
       Please Note: You must present to the FFL one valid Handgun Purchase Permit per handgun to be transferred. (e.g., You must have three (3) valid Purchase Permits to pick up three (3) handguns)
    - The \$25.00 fee you pay the auctioneer (per firearm purchased) for local pick-up covers all costs associated with this transfer.
  - If as a resident of North Carolina you elect to not conduct a local Winston-Salem pick-up and have it shipped to an FFL closer to you – then the out of state resident bullet point which directly follows this sentence will also apply to you.
- For All Residents of States <u>other than</u> North Carolina (and North Carolina residents who choose to have the handgun shipped to another NC FFL) the handgun will have to be shipped to an FFL in your resident state.
  - o It is up to the purchaser to select their local FFL of choice.
    - Please communicate via email the name and phone number of the chosen FFL to the auctioneer.
    - In that email also list your name and contact phone number so that that information can be included with the handgun being shipped so your FFL can contact you upon receipt of the handgun.
  - The Local Winston-Salem FFL will ship the handgun to the local FFL of your choosing.
     The \$45.00 fee you pay to the auctioneer (per firearm purchased) covers the packaging, shipping, and insurance on your handgun.
  - Once your handgun has arrived at your FFL. You will then have to go to your local Federal Firearm Licensee, abide by your local law requirements for the purchase of a handgun, fill out the appropriate paperwork, and pay any appropriate fees charged by your local FFL.

## **Instructions Regarding Transfer of Firearms**

## **Long Gun Purchases**

- Purchasers of any state may elect to travel to the Winston-Salem, NC Federal Firearms Licensee to affect their transfer of a Long Gun.
  - Please note, however, that if you are an out of state resident and travel to Winston-Salem, the local FFL will have to abide by the laws of your resident state to affect the transfer. (For example: Florida residents have a three day or five day waiting period (depending on the county of residency) <u>after</u> filling out paperwork and being approved before taking possession of the long gun.)
  - Additionally, some states restrict the features (folding stock, threaded barrels, etc) that
    are permitted on lawfully possessed long-guns. (e.g. New York, New Jersey, et al). The
    local FFL must abide by your home restrictions. If you cannot legally own the firearm in
    your state, you cannot travel to North Carolina and not be bound by the same
    restrictions.
  - The \$25.00 fee you pay the auctioneer (per firearm purchased) for a local pickup covers all costs associated with this transfer.
- Purchasers of any state (including NC) who do not wish to travel to Winston-Salem, NC to pick up their long-gun may elect to have their long-gun shipped to a Federal Firearms Licensee of their choice.
  - o It is up to the purchaser to select their local FFL of choice.
    - Please communicate via email the name and phone number of the chosen FFL to the auctioneer.
    - In that email also list your name and contact number so that that information can be included with the log-gun being shipped so your FFL can contact you upon receipt of the long-gun.
  - The Local Winston-Salem FFL will ship the long-gun to the local FFL of your choosing.
     The \$65.00 fee you pay to the auctioneer (per firearm purchased) covers the packaging, shipping, and insurance on your long-gun.
  - Once your long-gun has arrived at your FFL. You will then have to go to your local FFL, abide by your local law requirements for the purchase of a long-gun, fill out the appropriate paperwork, and pay any appropriate fees charged by your local FFL.
