RESTRICTIVE COVENANTS

The Restrictive Covenants made this 2 day of December, 1992, by Steve Aheron and wife, Beth Anne Aheron, said property being described in Deed recorded October 13, 1992, in Deed Book 872, at page 401, Rockingham County Registry, containing 11.05 acres, more or less.

This property, shall, as developed for residential use, be subject to the restrictive covenants set out, to which, this property, they shall now and immediately apply:

1. No mobile homes permitted.
2. All houses must be stick-built on site.
3. No cows, pigs, chicken, or other typical farm animal, may be permitted on property.
4. Horses for pleasure-use may be permitted (No more than 1 per 2 acres, unless approved by developer).
5. Houses must be at least 65 feet from edge of road.
6. No junk accumulation, or items that are inappropriate.
7. All wells must be located near the road and septic systems in back of house. Wells must be 50 feet from the house and 100 feet from the septic system.
8. No inoperative or unlicensed motor vehicles or parts of the same shall be permitted.
9. No dumping, or accumulation of trash, garbage, or other debris shall be permitted.
10. No lot may be subdivided. All residence shall be single family private dwellings.
11. All residence shall have a minimum of 1250 square feet of indoor heated area. Garages and basements cannot be figured in this computation.
12. Any questionable situations or disputes over these restrictions will be decided according to the judgement of the Developer.

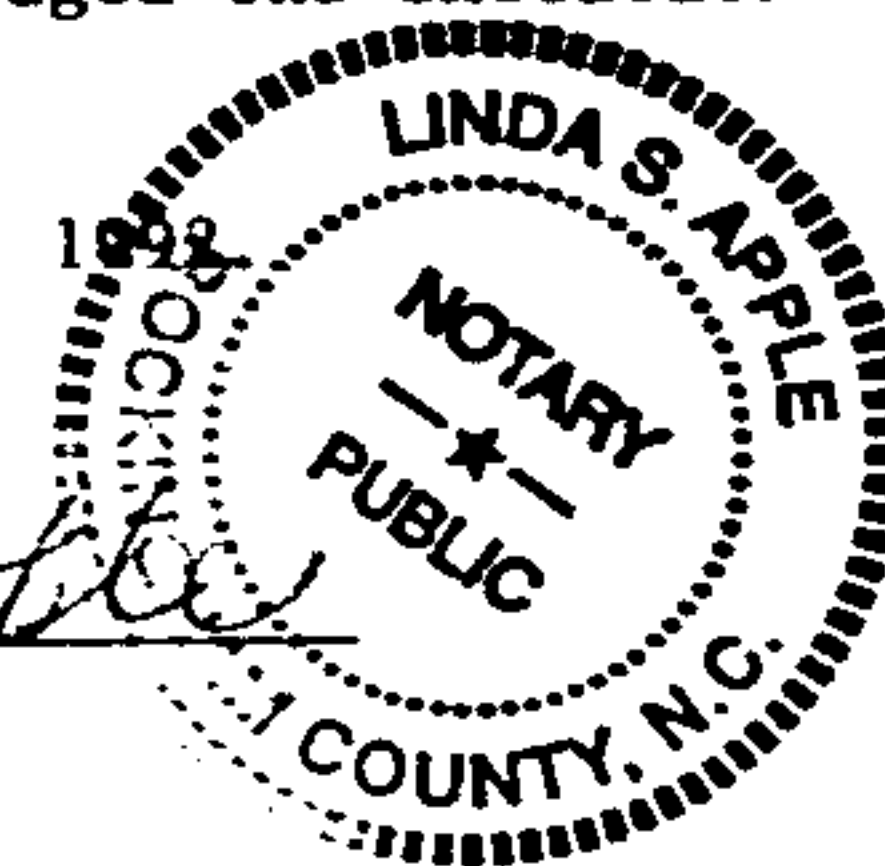
